- 2. THE OFFICE WILL CALL THE PERSON(S) MAKING APPLICATION TO ARRANGE A MEETING AT THE PROPERTY.
- **3.** AFTER THE MEETING, THE MAINTENANCE DEPT. SUBMITS INFORMATION TO THE OFFICE.
- **4.** THE OFFICE PREPARES AN APPLICATION, EASEMENT AND PROPOSAL, AS WELL AS ANY OTHER INFORMATION THAT IS NEEDED AND SENDS TO THE POTENTIAL PATRON. ****b**
- **5.** THE POTENTIAL PATRON COMPLETES AND SIGNS THE PAPERWORK AND RETURNS IT TO THE OFFICE ALONG WITH A CHECK FOR THE ENTIRE AMOUNT DUE. **c
- **6.** THE CHECK IS DEPOSITED IN THE BANK UPON RECEIPT.
- **7.** THE POTENTIAL PATRON'S NAME IS PUT ON AN INSTALLATION LIST, ACCORDING TO THE DATE ALL PAPERWORK IS RECEIVED BY THE OFFICE. **d
- **8.** THE APPLICATION IS PRESENTED TO THE BOARD OF DIRECTORS FOR APPROVAL AT THE NEXT SCHEDULED MEETING FOLLOWING THE RECIEPT OF THE PAPERWORK AND MONEY.
- 9. THE PATRON IS BILLED MONTHLY FOR THE MINIMUM PLUS ANY WATER USED. **e
- **a THE PRE-APPLICATION CAN BE OBTAINED BY CALLING THE DISTRICT OFFICE.

 ONLY THE LANDOWNER CAN MAKE PRE-APPLICATION OR APPLICATION FOR WATER SERVICE.
- **b THIS IS DONE BY THE OFFICE WHEN TIME ALLOWS.
- **c BIDS ARE GOOD FOR 30 DAYS, AS STATED ON THE PROPOSAL SENT TO THE POTENTIAL PATRON. ALL PAPERWORK AND MONEY MUST BE IN THE OFFICE BEFORE BEING PUT ON THE INSTALLATION LIST. THE COST OF A NEW BENEFIT UNIT IS \$6,500 effective 7/1/2022 (subject to change).
